Processing of applications for issuance of licenses in form JKEL-1, JKEL-1A, JKEL-1B, JKEL-1W, JKEL-3, JKEL-3A, JKEL-4, JKEL-4C, JKEL-7, JKEL-7A & JKEL-7B.

ORDER No.: 274 OF 2021 DATED: 22 - 01 - 2021

Whereas, a non-refundable processing fee of Rs 1,000/- was imposed by Excise Commissioner, J&K for processing the applications for grant of Bar with Restaurant (JKEL-4) and Bar with Hotel (JKEL-3) licenses vide Excise Order No. 414 of 2005 dated 11-10-2005; and

Whereas, in terms of Excise Order No. 213 of 2015 dated 31-08-2015, the non-refundable processing fee prescribed vide aforementioned order was enhanced to Rs 10,000/- for processing applications for following type of licenses:

"JKEL-1, JKEL-1A, JKEL-1B, JKEL-1W, JKEL-3, JKEL-3A, JKEL-4, JKEL-4A, JKEL-4C, JKEL-7 & JKEL-7B"

Whereas, in supersession of above Excise Order No. 213 dated 2015 dated 31-08-2015, a non-refundable processing fee of Rs 20,000/- was prescribed for processing the applications for issuance of following licenses vide Excise Order No. 256 dated 2016 dated 16-08-2016:

"JKEL-1, JKEL-1A, JKEL-3, JKEL-3A, JKEL-4, JKEL-4A & JKEL-4C"

Whereas, the Government vide Excise Policy 2018-19 (SRO 240 dated 29-05-2018), continued the provision with respect to following licenses (i.e. present processing fee):

"JKEL-1 & JKEL-1A"

Whereas, the above non-refundable processing fee was revised by the Government vide Excise Policy 2018-19 (SRO 240 dated 29-05-2018) and a non-refundable processing fee of Rs 50,000/- was prescribed for the below mentioned licenses:



"JKEL-1, JKEL-1A, JKEL-3, JKEL-3A, JKEL-4, JKEL-4A, JKEL-4B, JKEL-4C, JKEL-7, JKEL-7A, JKEL-7B & JKEL-7C"

Whereas, the above provision of processing fee continued upto the Excise Policy 2019-20 (SRO 128 dated 25-02-2019); and

Whereas, the above provision of payment of non-refundable processing fee for grant of licenses has been excluded in the Excise Policy 2020-21 issued by the Finance Department vide S.O. 275 dated 31-08-2020 which resulted in increase in number of applications for grant of licenses and majority of these application did not fall in the purview of laid down rules/ norms; and

Whereas, the payment of non-refundable application fee is required to check the number of applicants and to ensure smooth working of Excise Department; and

Whereas, the issue of exclusion of provision of remittance of non-refundable processing fee in the Excise Policy 2020-21 (S.O. 275 dated 31-08-2020) was taken up with the Finance Department, J&K and discussions were held with the Financial Commissioner, Finance Department, in his office chambers on 18-01-2021. It was decided during the meeting that Excise Commissioner can also issue the order of imposition of processing fee as done earlier.

Now, therefore, in view of the above position, a non-refundable processing fee of Rs 50,000/- (Rupees Fifty Thousand Only) is hereby prescribed to process the applications for grant of below mentioned licenses:
