Whereas, the Deputy Excise Commissioner, (Accounts), Jammu vide letter No. DECAJ/ACCTJ/1240 dated 19-11-2020 furnished the Minutes of Meeting of Committee constituted vide Order No. 37-EC of 2020 dated 06-06-2020 held on 18-11-2020 for classification of different brands of IMFL and imported liquor, and fixation of MRP of local brands of IMFL as per Annexure – "B-7" & Annexure – "B-8"; and

Whereas, the Deputy Excise Commissioner, (Distilleries), Jammu vide this office letter No. EC/Exc/MRP/2020-21/5464-65 dated 06-01-2021 was requested to intimate whether the requisite label fee has been recovered in accordance with clause 11 of the current Excise Policy 2020-21; and

Whereas, the Deputy Excise Commissioner, (Distilleries), Jammu vide letter No. DECDJ/2454 dated 13-02-2021 has submitted that the label fee of brands falling at S. No. 5, 6 and 9 of the minutes of meeting of committee dated 18-11-2020 (i.e. "Nok Blended Whisky", "Royal Choice Whisky" & "Mood Maker XXX Rum"), recommended vide letter No. DECAJ/ACCTJ/1240 dated 19-11-2020 has been received in accordance with clause 11 of the Excise Policy 2020-21. Whereas, the MRP sheet as recommended by the committee i.e. Annexure - "B7" (Low Cost IMFL brands) of minutes of meeting contains three brands of M/s Rockland Distilleries Pvt.
