Whereas, the Deputy Excise Commissioner, (Accounts), Jammu vide letter No. DECAJ/ACCTJ/1781 dated 01-02-2021 furnished the Minutes of Meeting of Committee constituted vide Order No. 37-EC of 2020 dated 06-06-2020 held on 30-01-2021 for classification of below mentioned brands of IMFL meant for Sale in Civil Market:

Whereas, while scrutiny of the "License Agreement", executed between M/s Kashmir Bottlers, Phase-1, SIDCO, Industrial Growth Centre, Distt. Samba-184121

(J&K) and M/s Radico Khaitan Ltd., Bareilly Road, Rampur-244901 U.P., it was observed that M/s Kashmir Bottlers has been shown as a company duly registered under the Companies Act, 1956, whereas, as per the license of the bottling plant i.e. License No. 11/JKEL-6, granted on 06-01-2017, the bottling plant is a proprietary concern and Shri Ram Paul Sharma, being the proprietor. Also, "Schedule-B" as indicated in the "License Agreement" was not enclosed and the list of brands authorized to M/s Kashmir Bottlers for manufacturing was not mentioned in the agreement; and

Whereas, in view of the above observation, the Deputy Excise Commissioner, (Accounts), Jammu and the Deputy Excise Commissioner, (Distilleries), Jammu vide this office letter No. EC/Exc/MRP/2020-21/KB/6852-53 dated 17-02-2021 were requested to furnish comments in the matter; and

Whereas, The Deputy Excise Commissioner, (Distilleries), Jammu vide letter No. DECDJ/2560 dated 23-02-2021 submitted that the License/Franchise agreement needs to be corrected by the licensee before approval of classification of franchise brands; and

Whereas, the Deputy Excise Commissioner, (Accounts), Jammu vide letter No. DECAJ/ACCTJ/1833 dated 16-03-2021 furnished new copy of "License Agreement" having rectified the above observation and a copy of "Schedule-B" of the agreement indicating list of brands authorized to M/s Kashmir Bottlers for manufacturing; and

Whereas, the Deputy Excise Commissioner, (Accounts), Jammu vide this office letter No. EC/Exc/Classification/2020-21/293-94 dated 07-04-2021 was requested to furnish valid documents as the earlier one submitted to this office are not in original form, and not attested/registered by the Competent Authority; and

Whereas, the Deputy Excise Commissioner, (Accounts), Jammu vide letter No. DECAJ/Exc/Acctts/121 dated 08-07-2021 furnished fresh "License Agreement", in original, executed between the M/s Radico Khaitan Limited (signed by Mr Lalit Gupta, Dy. Manager-Sales) and M/s Kashmir Bottlers (signed by Mr Ram Paul Sharma, Proprietor) duly registered by Sub-Registrar, Assistant Commissioner (Rev) Samba Tehsil Samba; and

Whereas, it was observed that the Committee had recommended for classification of above brands as per Excise Policy 2020-21 (S.O. 275 dated 31-08-2020), which was valid upto 31-03-2021. As such, the case was referred to the Departmental Chemist for his view in light of current Excise Policy 2021-22 (S.O. 114 dated 31-03-2021); and

Whereas, the Departmental Chemist submitted that the brands at S. No. 2 & 3 in the above table, were recommended in "Economy" segment as per the previous Excise Policy (2020-21), but now as per clause 4.5 of the Excise Policy 2021-22 (S.O. 114 dated 31-03-2021) and on the basis of EDP these two brands now fall in the "Medium" category/segment; and

Whereas, the matter was again referred to the Deputy Excise Commissioner, (Accounts), Jammu to consider the same in the Committee in light of current Excise Policy 2021-22 (S.O. 114 dated 31-03-2021); and

Whereas, the Deputy Excise Commissioner, (Accounts), Jammu vide letter No. DECAJ/Acctts/226 dated 29-07-2021 submitted that the matter was placed before the Committee and furnished the recommendation of the Committee as per clause 4.5 of the Excise Policy 2021-22 whereby on the basis of EDP, the brands at S. No. 2 & 3 in the above table now fall in the "Medium" category/segment.

Now, therefore, in exercise of the powers conferred under Rule 38, sub rule 31 clause (b) sub clause (iv) of the J&K Liquor License and Sale Rules, 1984, read with S.O. 114 dated 31-03-2021 and recommendation of Deputy Excise Commissioner, (Accounts), Jammu and the Committee constituted vide Order No. 37-EC of 2020 dated 06-06-2020, sanction is hereby accorded to the classification of below mentioned brands of IMFL meant of Sale in Civil Market only in the category/ segment indicated against each:
