Whereas, as per clause 2.4.10 of the Excise Policy 2021-22 (S.O. 114 dated 31-03-2021), every licensee will have to deposit the Minimum Guaranteed Revenue (MGR) on account of applicable Excise Duty/ Fee, indicated against each vend as per procedure prescribed. The MGRs has to be divided into twelve equal installments to be deposited on 1st of every month by the licensee or as the case maybe; and

Whereas, the Minimum Guaranteed Revenue (MGR) comprises of "Assessment Duty", "Additional Assessment Duty", "Additional License Fee" & "Others/Rounding Fee", needs to be segregated for more clarity to the licensees.
