Whereas, the committee constituted vide Order No. 37 EC of 2020 dated 06-06-2020 forwarded the Minutes of Meeting bearing No. DECAJ/Exc/Accts/235-40 dated 30-07-2021 held on 28<sup>th</sup> July, 2021; and

Whereas, the committee deliberated upon the classification of brands, adopting the following parameters as per clause 4.5 of the current Excise Policy 2021-22 (S.O. 114 dated 31-03-2021):

Whereas, as per the Minutes of Meeting, M/s Vedant Bottlers Pvt. Ltd., 511, Jodhpur Park, 3<sup>rd</sup> Floor, Kolkata-700068 has executed an agreement with M/s Dogra Distilleries, Village Gangyal, Tehsil & Distt. Jammu, J&K to manufacture their products in J&K. The prescribed label fee of above brands @ Rs 50,000/- per brand has been deposited vide Collection ID 210621152936ZPS dated 21-06-2021 amounting to Rs 2,00,000/-; and

Whereas, the Deputy Excise Commissioner (Accounts), Jammu vide letter No. EC/Exc/MRP/2021-22/Part-II/4956-57 dated 12-08-2021 was requested to intimate whether other brands of these companies are being sold in UT of J&K or first time the company is introducing brands in J&K; and

Whereas, the Deputy Excise Commissioner (Accounts), Jammu vide his office letter No. DECAJ/Exc/Accts/291-93 dated 18-08-2021 referred the matter to the Deputy Excise Commissioner (Distilleries), Jammu to provide the information to the office of Excise Commissioner, J&K; and

Whereas, Shri Aditya Bakshi, Vice President Sale and Marketing for Vedant Bottlers Pvt. Ltd. submitted an affidavit in this office deposing therein that his

company has not registered/classified any of their brands in the UT of Jammu & Kashmir at present thus none of their brands are sold in the UT of Jammu and Kashmir at present; and


Whereas, the aforementioned affidavit, in original, was forwarded to the Deputy Excise Commissioner (Distilleries), Jammu vide this office letter No. EC/Exc/MRP-2021-22/11/5540-41 dated 31-08-2021 for information and further necessary action; and

Whereas, the Deputy Excise Commissioner (Distilleries), Jammu vide letter No. DECDJ/1745 dated 02-09-2021 submitted that the aforesaid brands have neither been classified nor in production in Jammu & Kashmir till date; and

Whereas, the Deputy Excise Commissioner (Distilleries), Jammu vide this office letter No. EC/Exc/MRP/2021-22/6752-54 dated 22-11-2021 was requested to furnish fresh recommendation in the matter; and

Whereas, the Deputy Excise Commissioner (Distilleries), Jammu vide letter No. DECDJ/2557 dated 30-11-2021 submitted that M/s Dogra Distilleries, Village Gangyal, Tehsil & District Jammu holding license No. 08/D-2 has entered into tie-up agreement with M/s Vedant Bottlers Pvt. Ltd., 511, Jodhpur Park, 3<sup>rd</sup> Floor, Kolkata-700068 for bottling of the aforementioned brands. The agreement stands registered before the Sub-Registrar (Assistant Settlement Officer, Jammu) on 02-06-2021. The brands have been recommended by the Price Fixation Committee for classification after examining the request of the licensee.

Now, therefore, in exercise of the powers conferred under Rule 38, sub rule 31 clause (b) sub clause (iv) of the J&K Liquor License and Sale Rules, 1984, read with S.O. 114 dated 31-03-2021 and recommendation of the Committee constituted vide Order No. 37-EC of 2020 dated 06-06-2020, sanction is hereby accorded to the classification of aforementioned brands in "Premium" segment/category meant for Sale in Civil Market in J&K only.
