Whereas, the Joint Chief Electoral Officer, UT of Jammu and Kashmir vide letter No. 2134/CEO/ME/2020/1874 dated 26-11-2020 has enclose the above notification and requested for issuance of corrigendum in this regard.

Now, therefore, in partial modification of Order No. 186 of 2020 dated 16-11-2020 issued under endorsement No. EC/Exc/Misc/F-008/4105-32 dated 16-11-2020, the dry days in respect of elections for vacant seat of 'Municipal Council Pulwama' shall be observed from 17-12-2020 (2:00 p.m. to 19-12-2020 (2:00 p.m.) instead of 05-12-2020 (2:00 p.m.) to 07-12-2020 (2:00 p.m.).
