Whereas, the Joint Chief Electoral Officer, UT of Jammu and Kashmir vide letter No. 2134/CEO/ME/2020/1123-26 dated 08-11-2020 has requested this office for notifying 'dry days' in the Municipal Areas going to poll/ counting as per the schedule for the conduct of free and fair Municipal By-Elections, 2020 in the UT of Jammu and Kashmir; and

Whereas, Section 135C of Representation of the People Act, 1951 provides as under:

"No spirituous, fermented or intoxicating liquors or other substances of a like nature shall be sold, given or distributed at a hotel, eating house, tavern, shop or any other place, public or private, within a polling area during the period of forty-eight hours ending with the hour fixed for the conclusion of the poll for any election in that polling area."

Now, therefore, in view of above provision of Section 135C of Representation of the People Act, 1951 and request made by the Joint Chief Electoral Officer, UT of Jammu and Kashmir, it is hereby ordered that liquor vends/ trades/ outlets selling liquor on/ off the premises operating within the Municipal Corporations/Councils/Committees in the Jammu & Kashmir shall remain closed as per the schedule mentioned below:
