SRO-206.- In exercise of the powers conferred by subsection (1) of section 3 of the Jammu & Kashmir Levy of Tolls Act, Smvt. 1995 (Act No. VIII of 1995) and in supersession of notification SRO-156 dated 30th May, 2016 read with notification SRO-177 dated 1st June, 2016, the Government hereby direct that the Toll on vehicles of various types and goods shall be levied at the Toll Stations at the rates specified in **Annexure 'A', Annexure 'B' and Annexure 'C'** to this notification.

This Notification shall come into force w.e.f. 01.07.2016.
