### **NOTIFICATION** Srinagar, the 5th June, 2009.

SRO 162 - In exercise of the powers conferred by section 16 read with section 16-A and section 17 of the Jammu and Kashmir Excise Act, Samvat 1958 and in supersession of all the notifications/orders issued on the subject, the Government hereby direct that the excise duty and fee on Import/Export, possession, manufacture, bottling and sale etc. of IMFL/Beer under the provisions of the said Act in respect of civilian and Army/Para Military Force use, shall be levied and paid at the rates shown against each in the sub-joined table with immediate effect:-

All liquor manufactured locally or imported from outside the State shall be ENA based only and use of rectified spirit in manufacture/sale of liquor for consumption in civil market and CSD/PMF shall remain banned.

The Additional Licence Fee payable shall be paid on monthly basis as soon as the threshold limit is crossed in accordance with the prescribed procedure. However, in case of JK Desi Whisky there shall be no threshold limit and additional Licence fee shall be charged right from the sale of first bottle from the date of issue of this notification.

There will be ban on import of Economy/cheap brands for consumption in civil market.

Assessment Fee payable shall be paid on quarterly basis in accordance with the prescribed procedure.
