Assessment fee shall be payable on monthly basis instead of quarterly basis in accordance with the prescribed procedure.

Whereas, the Additional License fee is being realized on monthly basis by or before 7<sup>th</sup> of every month in term of Excise Order No. 399 of 2004 dated: 30-09-2004.

Whereas, Assessment fee is being realized on quarterly basis on 15<sup>th</sup> of the month ending each quarter.

Whereas, now both, the Assessment fee and Additional License fee, are to be collected on monthly basis.

Now, therefore, in terms of SRO 107 dated: 28-03-2012, SRO 157 dated: 26-04-2012 and in partial modification of Excise Order No. 399 of 2004 Dated: 30-09-2004, it is hereby ordered that:-

- 1. Each licensee shall deposit the self assessed amount of Additional license fee and Assessment fee by or before 10<sup>th</sup> of every month. In case of failure on the part of the licensee to deposit the fee indicated above an additional sum equal to 2% of the amount due shall be charged under Section 24-A of the Excise Act, 1958.
- 2. The licensee thereafter shall produce the treasury cash receipt (F.C. 2) along with copy of sale statement in the proforma before the Excise and Taxation Officer concerned with a copy to the Deputy Excise Commissioner concerned and the Excise Commissioner in his office at Jammu.

- 3. The Excise and Taxation Officer concerned will verify the self assessed amount of Additional License fee and Assessment fee and after cross checking with the sale register raise a demand for any amount found less deposited by the ticensee which shall be payable with-in three days.
- 4. A consolidated report in the enclosed proforma shall be submitted by the Excise and Taxation Officer concerned on monthly basis by or before 12/13 of each month to the Excise Commissioner, Deputy Excise Commissioner, Executive concerned with a copy to the Deputy Excise Commissioner, Accounts, Jammu as well.

This order is effective with immediate effect.
