Notification, Jammu, the 2724 April, 2010.

## 1. after rule 8 the following shall be added as rule 8-A;

"8-A In a case where a license is granted to an individual, a member of the family of the licensee may be incorporated as a partner by the Licensing Authority during the currency of a license on an application made in writing by the licensee giving sufficient and cogent reasons and on payment of non-refundable processing fee of Rs.10,000/- if the family member is otherwise eligible under these rules for grant of such License.

Provided that in case of license in form JKEL-IA and JKEL-6, the Licensing Authority may for reasons to be recorded in writing, add partner(s) outside the family during the currency of a license on payment of non-refundable processing fee of rupees fifty thousand of the proposed partner(s) are otherwise eligible for grant of license under these rules:-

- In rule 9, the words "subject to payment of non-refundable processing fee of rupees ten thousand" shall be inserted between the words "license" and "may";
- 3. **in rule 11** between the words 'partners' and 'a' the words "and on payment of a non-refundable processing fee of rupees ten thousand" shall be inserted:

- 4. **in rule 12** between the words 'partners' and 'a' the words "and on payment of a non refundable processing fee of rupees ten thousand" shall be inserted; and
- 5. in rule 23 under the heading 'limit of retail sale';
  - (i) the entry appearing against column 'a' shall be substituted by the following:
    - "9 bulk liters or 12 bottles of the capacity of 750 milliliters"; and
  - (ii) the entry appearing against column 'b' shall be substituted by the following:-
    - "7.80 bulk liters or 12 bottles each of the capacity of 650 milliliters"
- 6. in clause (i) of sub-rule(10) of rule 38,the following proviso shall be added; namely:-

"Provided that the Commissioner may by notification prohibit the sale of liquor for 48 hours before the close of polling and before the days of counting in any area where election to the Lok Sabha and or State Legislative Assembly is to be conducted by the Election Commission of India".

7. **In clause (a) of rule 39** after the words 'Excise Commissioner' the words "and subject to payment of non-refundable processing fee of rupees five thousand" shall be added.
