NOTIFICATION  
JAMMU THE 26th FEBRUARY 2004

SRO 58 .- In exercise of the powers conferred by section 3A, 12, 20 and 25 of the Jammu and Kashmir Excise Act, Samvat 1958, the Government hereby make the following amendments in the Jammu and Kashmir Liquor Licence and Sales Rules, 1984, namely:-

- (I) After sub-rule (7) of rule 30, the following shall be added as sub-rule 8: -

"Pending completion of the procedure, here-in-above, the Excise Commissioner, may, if the situation so warrants in the interest of Government revenue, grant a temporary licence for retail vending of liquor at a premises, previously notified by the department, for a period not exceeding four months, to be followed either by grant of a regular licence, licence under the rules on completion of the procedure or termination of the temporary licence in the event of non completion of the procedure."

- (II) In clause (ii) of sub-rule (31) (b) of rule 38; -

- (a) "full stop(.)" after the words 'intended to pass as gin' shall be deleted and the words 'and of a strength of 40 degree under proof in the case of Indian Made Foreign Liquor branded as JK-Desi Whisky or spirit intended to pass as JK-Desi Whisky" shall be inserted;

- (b) a proviso shall be added at the end of clause (ii) as under: -

"Provided that the Indian Made foreign Liquor branded as JK-Desi Whisky shall not be sold in bottles and/ or pouches except of the following sizes:-

- a) Bottles or pouches of 750 ml.
- b) Bottles or pouches of 375 ml.
- c) Bottles or pouches of 250 ml.
- d) Bottles or pouches of 180 ml."

This notification shall come into force with immediate effect.
