## NOTIFICATION JAMMU, THE 29th February, 2004.

SRO 64.- In exercise of the powers conferred by section 16 read with section 17 of the Jammu and Kashmir Excise Act, Samvat 1958, the Government hereby direct that in Notification SRO 204 dated 26th June, 2003, the following amendments shall be made ,namely:-

In item No. 1-A the following shall be added as entry (iii) and the existing entries (iii) and (1) (iv), shall be re-numbered as (iv) and (v) respectively:

5-A Additional Licence Fee

Additional licence fee for each bottle of 750 ml shall be charged from the following categories of licences at the rates indicated each:-

The Additional Licence Fee payable shall be paid on monthly basis as soon as the threshold limit is crossed in accordance with the procedure to be prescribed by the Excise Commissioner.

This shall come into force with effect from 01.04.2004
