Notification

Jammu, the 3<sup>rd</sup> March, 2000

S.R.O. *G.D.* In exercise of the powers conferred by sections 3A, 12, 20 and 25 of the Jammu and Kashmir Excise Act, Samvat 1958, the Government hereby make the following amendments in the Jammu and Kashmir Liquor Licence and Sale Rules, 1984, namely:-

1. In rule 4, after entry JKEL-1, the following shall be added:-

JKEL-1A	Wholesale vend of foreign liquor to the manufac- turer outside the state for sale to JKEL-1	Fixed fee or any other or private contract	Excise Commissioner	Excise Commissioner

2. In rule 7 full stop appearing after the words 'premises' shall be omitted and the following words shall be added, namely:-

"blue prints whereof shall be got approved by the Excise Commissioner. The premises so approved shall have only one entrance without window/ventilator."

3. The subjoined table below rule 18 shall be substituted by the following:-

"S.No	A licence in form	May not be held in conjunction with
(1)	JKEL-1	A licence in form JKEL-1A, JKEL-2, JKEL-3, JKEL-4, JKEL-7.
(2)	JKEL-1A	No other licence.

(3)	JKEL-2	JKEL-1A, JKEL-1, JKEL-12, JKEL-13 and JKEL-14.
(4)	JKEL-2, JKEL-1, JKEL-4 and JKEL-7	A licence in form JKEL-3A.
(6)	JKEL-8, JKEL-9, JKEL-10 and JKEL-11	A licence in form JKEL-1A, JKEL-12, JKEL-13 and JKEL-14.
(7)	JKEL-12	A licence for any dealings in country liquor or for the vending or rectified spirit.

4. Rule 19 shall be substituted by the following :-

- "(1) No person holding a licence for a distillery may hold any licence under these rules except a licence in form JKEL-8.
- (2) No person holding a licence for brewery shall hold any licence under these rules."

5. In rule 20 after the letters and figure "JKEL-1" the letter and figure "JKEL-1A" shall be inserted.

6. In rule 22 the letters and figure in form "JKEL-8" shall be deleted.

7. Rule 32 shall be recast as under :-

"The following scale of fixed fees is hereby provided :-

(i)	For a licence in form JKEL-1	Rs. 1.00 lac. (one lakh)
(ii)	For a licence in form JKEL-1A	Rs. 1.50 lac. (one & half lakhs)
(iii)	For a licence in form JKEL-2	Rs. 1.00 lac. (three lakhs)
(iv)	For a licence in form JKEL-3	Rs. 1.00 lac. (one lakh)
(v)	For a licence in form JKEL-4	Rs. 1.00 lac. (one lakh)
(vi)	For a licence in form JKEL-5	Rs. 1.00 lac. (one lakh)
(vii)	For a licence in form JKEL-6	Free
(viii)	For a licence in form JKEL-7	Rs. 10,000/- (Ten Thousand)
(ix)	For a licence in form JKEL-12	Rs. 200/- per annum for a licence possessed in quantity not exceeding 2000 ml., at the time and if it exceeds the quantity of 2000 ml. the fees shall be Rs. 300/-.
(x)	For a licence in form JKEL-13	Rs. 1.00 lac. (one lakh)
(xi)	For a licence in form JKEL-14	Free"

8. In rule 35 after the words "are departmentally" and before the words "in respect of" the words "or in any other manner" shall be inserted.

9. In sub-rule 31(b) (iii) of rule 38, entry (e) shall be deleted.

10. In sub-rule (1) of rule 39 after the letters and figure "JKEL-I", the letters and figure "JKEL-IA" shall be inserted.

11. After sub-rule (11) of rule 39, the following shall be added as sub-rule (15), namely:-

LICENCE IN FROM JKEL-IA,

"15 (i) The licensee shall maintain regular and proper accounts of receipt and sales in Register Form E-13 and shall at the end of each month prepare and submit to the Excise and Taxation Officer incharge Excise Range, a monthly true abstract of receipts and sales in Register Form E-19. He shall also maintain a brand-wise register.

(ii) The liquor shall be sold in sealed / caged bottles only and in no case shall these be opened or sold in part by the licensee nor shall he allow consumption of liquor of any kind on the licensed premises.

(iii) The liquor shall be sold to JKEL-I licensee only

12. (A) In Register Form E-13 after the letters and figure "JKEL-I" the letter and figure "JKEL-IA" shall be inserted.
