- At the end of entry No. 8, after the words "per piece", the words "except locally extracted and processed marble stones" shall be added.
- 3. Entry No. 19 shall be recast as: -

"Oil cakes, Wheat bran, Maize bran and Rice bran except when imported for manufacture of poultry and cattle feed" by the units.

This notification shall come into force with effect from 01.04.2008.
