#### Jammu, the 31st March, 2015

SRO 108.- In exercise of the powers conferred by subsection (1) of section 3 of the Jammu & Kashmir Levy of Tolls Act, Smvt. 1995 (Act No. VIII of 1995), and in supersession of all previous notifications and orders issued on the subject, the Government hereby direct that the Toll on vehicles of various types and goods shall be levied at the Toll Stations at the rates specified in Annexures 'A', 'B' and 'C' to this notification .

This Notification shall come into force w.e.f. 01.04.2015.
